4187 To approve and sign the 2016/17 audit accounting and annual governance statements

It was resolved to approve the accounting and annual governance statements. These were signed by MB as Chairman.

Two recommendations had been received with regards to a minor revision to the figures on the accounting statement, which has been made, and a revision to the standing orders which will be resolved under minute 4189.

4189 To consider adopting revised standing orders

It was resolved to adopt the revised standing orders.

4190 To consider requesting the West Berkshire Speed Limit Review considers implementation of a 20mph speed limit from the Surgery on the High Street to the Railway Bridge on School Road

WBC have advised that it would not be possible to get two separate 20mph speed limits on School Road outside the Primary School and on the High Street around the area of the shops and therefore it was suggested the PC look at one 20mph speed limit running from the Surgery to the Railway Bridge.

It was resolved to request WBC consider this speed limit at their next Speed Limit Review Task Group.

4191 To consider adopting a revised grant policy

It was resolved to adopt the revised grant policy.

4192 To consider quotes to reprint the footpaths leaflet

It was resolved to accept a quote from Keeps Printing.

4193 To consider paying the costs for the digitisation of old films of Compton

MB advised that he had the necessary equipment to digitise VHS and would be willing to digitise the VHS that Alison currently has. If any other formats are found the Parish Council will consider this again at a future meeting.

4194 To consider quotes for additional items of play equipment in the Recreation Ground and applying for funding under the Member's Bid process

RP has met with AMV who install gym equipment which they believe they will be able to source funding for. The Clerk will complete the application form for AMV to begin searching for funding. The Clerk and RP are to liaise on which equipment should be selected for the package.

The parish council agreed they wish to install a wooden 20m zip wire. The Clerk and RP will seek quotes.

4195 To consider quotes for the street lighting maintenance contract

It was agreed that further information was required so this item was deferred.

4196 To receive an update on vandalism and anti-social behaviour (ASB) in the village

There was nothing to report.

4197 To receive reports on the following:

b) Football Pavilion

The heaters have been installed to dry out the pavilion.

c) Rights of Way

The surface of byway 2 has been significantly improved.

There is a problem with signage on the Ridgeway, resulting in people going the wrong way. AS will photograph and report.

The condition of the handrail on the steps leading from Old Station has previously been queried. A member of the council had inspected it and determined it was very stable. However, it was highlighted that the gap underneath it would be easy for a child to fall through. AS will inspect this.

A query was made as it was stated there used to be a memorial trough with a tap alongside byway 2. The site owners will be contacted to discuss if this could be reinstated.

e) Allotments

There have been complaints regarding the noise from cockerels at Newbury Lane. MB and the allotment manager are trying to resolve this.

f) Patient Representation

An email had been received earlier in the day from the Practice Manager showing that there is no doctor at Compton surgery on Monday or Wednesday. Figures for unfilled and 'did not attend' appointments were given for all appointments but it was noted that the total number of appointments was not given in order to see the percentages of appointments affected.

g) Communications

The new website is now live and the domain name is being hosted locally at cost, along with a new domain name for the Neighbourhood Development Plan website. There is some additional documentation still to be put on the site.

We are awaiting further information from the planning officer with regards to the planning application for the burial ground.
