The council requested the clerk write a letter to Richard Benyon, MP, to protest about the cuts and highlight the impacts on a rural community such as Compton.

The Downland Practice was recently inspected and was rated as good overall. It was noted that the report states they did not visit the Compton branch.

## 3779 To consider quotes for a company to devise an initial strategy for a neighbourhood plan

No quote had been received. The Clerk was requested to contact the company.

## 3780 To consider activities to commemorate the Queen's 90th birthday

A sample of a commemorative medal was viewed by the council, however it was agreed they did not want to provide commemorative medals. AS is continuing to obtain quotes for two oak trees for planting in commemoration.

#### 3781 To consider whether to end the contact for supply of the bin at the Wilkins Centre

PB declared an interest in this item.

It was resolved that, as the council no longer employs a litter picker, the bin is no longer needed and the contract should be cancelled.

#### 3782 To consider ensuring that adverts in Compilations are to be prepaid from 1st April

It was resolved that advertising should now be prepaid. The Clerk was requested to implement this as soon as was possible.

# 3783 To consider the appropriate method of repayment for the loan made for improvements to the Scout Hut toilets

#### Rights of Way

#### d) Village Hall

Work has been carried out in the Wilkins Centre to remove the bath and revise the plumbing, creating more storage space.

#### h) Groundwater

The following report was received from the Flood Warden:

The trash screen at Ilsley Road/Fairfield has been installed. It will be interesting to see if it has any effect next season on the debris that accumulates at the entrance to the High Street culvert. I will arrange for this season's accumulation outside Bramley Cottage (formerly Towyn) to be removed after Easter. The current threat from groundwater remains slight as the aquifer is just about 50% full, well below previous peaks. Roadside gullies responsible for poor surface water drainage that were reported to Highways have been addressed by WBC's contractor. The obstructed outflow into the watercourse from the gulley in the corner of the lay-by at the bottom of Churn Road has been rectified, but in a rather rudimentary manner. In High Street by the sarsen stone and in the vicinity of the sewage pumping station on Aldworth Road, flooding is caused by residual structural/blockage issues. I have been promised an update from Highways Maintenance, and will follow up as necessary.

#### 3790 To receive the finance report and approve payments due

It was resolved to approve the payments listed on the finance report, which is at Attachment 2.

The Clerk went through her report, which is at Attachment 1.

#### 3792 Matters for future consideration and information

IT, KS and MB will meet to discuss document storage.

MB and the Clerk carried out the annual internal audit, everything was found to be generally in order.

The standard of pot hole repair was discussed. The Clerk was requested to contact West Berkshire Council for information on the specifications for these repairs.

The parish assets and management working party highlighted some queries regarding what land and buildings they should approach the BBSRC for in order to attempt to obtain them. A meeting will be arranged with Powis Hughes, the agents, as soon as possible.
