MINUTES of the COUNCIL MEETING

Held on Monday 6th June 2011 at 7pm in the Welstead Room, Compton Village Hall.

Those present: Councillors D Aldis (chair), P Shanks, M Pinfold, L Moss, K Simms, and P Whitworth

In attendance: R Palmer (Clerk) and 3 members of the public

The meeting started at 7.05pm.

2382 Apologies for absence

Apologies had been received from Parish Councillors A Strong and M Birtwistle and District Councillor Virginia von Celsing

2383 Any declarations of personal or prejudicial interest by members or the Clerk

LM declared a prejudicial interest in item 2398 (litter picker) DA and KS declared a personal interest in item 2405 (cheques)

- 2384 Declaration of acceptance of office by Councillor Aldis:
 - As Chairman of the Council for the year 2011/12
 - As a Councillor for the period 2011 to 2015

Councillor Aldis signed the two declarations, which were then countersigned by the Clerk.

2385 To receive statements from – and ask questions of - members of the public who wish to be co-opted on to Compton Parish Council to fill the one vacancy

Two people who wished to become parish councillors gave a short introduction and were then asked questions by councillors – see minute 2409 below.

- 2386 To receive:
 - **Questions or comments from members of the public**
 - > Representations from any member who has declared a prejudicial interest

A question was asked about the boat parked on Ilsley Road.

LM gave details of the work of the litter picker and answered questions.

2387 To approve the minutes of the Council Meeting (AGM) held on 9 May 2011

Proposed by LM, seconded by PS and carried. They were then signed by the Chairman.

2388 Matters arising from the minutes of the Council Meeting on 9 May 2011

The Clerk said he was still awaiting confirmation of the name of the owner of the land from which hedges and trees were overhanging Station Road.

2389 To approve the minutes of the Council Meeting held on 16 May 2011

Proposed by KS, seconded by MP and carried. They were then signed by the Chairman.

2390 Matters arising from the minutes of the Council Meeting on 16 May 2011

There were none.

2391 Clerk's report

The Clerk went through his report, which is at Attachment 1. He agreed to chase Southern Electric and the other contractor who were doing work on the football pavilion.

2392 To receive an update on vandalism and anti-social behaviour (ASB) in the village

LM said that no NAG meeting had been held recently. She said that a car window had been smashed last week; DA said there had been a spate of burglaries of garden furniture etc

2393 To receive a report on the actions being taken to investigate the possible continuance of service provision at the Downlands Day Care Centre after it closes in September

The Chairman said there was encouraging news, as a group proposed to use the centre 3 days a week, which could mean that continuation of the Day Care Centre could be viable.

2394 To receive an update on the redevelopment of Fairfield

The Clerk said that the new planning application had not yet been considered by West Berkshire Council.

2395 To receive an update on the current churchyard situation

The Clerk said he had received a second letter from the owner of land that could possibly be used as an extension to the existing churchyard. The owner had discussed the situation with his agent and he advised that this land would be under cultivation until the middle of September, after which tests of the land could go ahead.

KS said that the Council should also consider other possible sites in case this one proved unsuitable. Land adjacent to and above Newbury Lane allotments was suggested and also other land nearer the church. He proposed that the Clerk should make enquiries (possibly with the Environment Agency) to find out what initial tests could be done to ascertain whether or not any of the identified pieces of land would be suitable for use as a churchyard. This was seconded by DA and was carried.

- 2396 To receive a report from the sub-committee set up to open discussions with Powis-Hughes on how best the Parish Council can support BBSRC in its withdrawal from the village KS said the sub-committee had not met since the last meeting.
- 2397 To receive an update on West Berkshire Council (WBC) planning for the future of the IAH site, including the production of the Supplementary Planning Document (SPD)

 No report had been received since the presentation at the Annual Parish meeting on 16th May. The Clerk was asked to contact WBC to find out what were their immediate plans.
- 2398 To receive a report from the sub-committee set up to consider use of the Recreation Ground football pitches

The sub-committee still had not met and the Chairman asked them to agree this evening a date for the meeting.

2399 To consider changing the contract of the Village Litter Picker and increasing the number of litter bins and/or changing their locations

Following discussions, DA proposed that the monthly remuneration of the litter picker be increased from £55 to £70 per month for the months of May, June and July each year. This was seconded by PS and was carried.

The Clerk was asked to contact West Berkshire Council about a litter bin missing from the Recreation Ground

2400 To consider the recent RoSPA play area safety inspection report and approve any required works and recommendations

The Clerk said that most of the risks identified in the report were categorised as 'Low', although a few were 'Medium'. These were mainly trip hazards caused by uneven or worn surfaces. The Clerk was asked to contact Wicksteed Leisure about a repair kit for one of their surfaces and also find out if a volunteer group would be willing to help improve the play area surfaces.

2401 To consider the recommendations in the i-Transport Review Report (November 2010), the comments in the letter from West Berkshire Highways (21 January 2011) and the quote for a VAS Modular sign system and agree how best to spend the S106 money available for highway safety improvements
