21/00545/HOUSE 27 Lowbury Gardens, Compton, RG20 6NN - Partial conversion of existing garage into home office/study Resolved: To object to the application and submit the following comments: The original planning conditions for Lowbury Gardens state that garages must not be turned into part of the dwelling as they are essential for parking vehicles.

- **20/21-271** The Council became aware that works were being carried out at 31 Burrell Road that had involved the damage to the Council owned verge adjacent to the property. The Clerk was requested to write to the property owners giving permission for them to continue with the works proposed but highlighting that the Council will seek to instate a licence.
