2913 **Apologies for absence** were received from V. von Celsing.

2914 Any declarations of pecuniary interest by members or the Clerk

There were none.

2915 To receive: Questions or comments from members of the public

2916 To approve the minutes of the Council Meeting held on 11th February, 2013

Proposed by KS, seconded by LM and carried. They were then signed by the Chairman.

2917 Matters arising from the minutes of the Council Meetings on 11th February, 2013

2918 To receive a report from our District Councillor, Virginia von Celsing

VvC has sent her apologies.

2919 Clerk's report

The Clerk went through her report, which is at Attachment 1.

Item 4: The street light removed in the accident opposite Yew Tree Stables is still in one piece. Clerk to inform WBC.

2921 To discuss potential s.106 highway improvements and agree priorities

LM and PB met with representatives from West Berkshire Council and Sovereign.

- 1. It was considered the signage at the school is adequate but it may be possible to extend the double yellow lines and drop the kerb to improve the crossing to the Recreation Ground.
- 2. A footpath along the front of Lowbury Gardens would be too expensive. It may be possible to drop the kerb opposite the junction.
- 3. Outside the Doctors surgery drop kerbs could be installed at either side of the road by the gate in the wall. No traffic calming is required as there is a clear view.
- 4. It may be possible to install Grasscrete on the grass surfaces outside Manor Bungalows to aid parking.

5. Sovereign will contribute towards dropping kerbs and creating driveways at houses in Burrell Road. They will perform a letter drop to their residents. It may also be possible to install Grasscrete in places along this road.

A report will be provided to the Parish Council in due course.

MB will approach the homeowners of the bungalow on the corner of Down's Road about the possible installation of a pathway in front of the property.

The railing near the school is damaged. The Clerk is to write to WBC to request repair.

2922 To consider the replacement of the gate and hedge cutting at Newbury Lane Allotments

The hedge cutting has been covered under the grounds maintenance contract. The allotment manager has provided a quote to replace the gate/post. The Clerk is to request a further quote.

2920 To discuss the draft of the Supplementary Planning Document (SPD)

Liz Alexander and Sarah McCullough from West Berkshire Council discussed various aspects of the draft SPD with the Council.

The whole site covers 15 hectares, however, the developable area will be smaller as this will be the area available once the infrastructure (roads, open spaces, landscaping etc) are determined. WBC is unable to state housing numbers due to case law; they can only use the framework to guide this figure.

Although the schools are currently full to capacity, the education department believe they can provide the increase in capacity that will be required.

The document will be altered based on this consultation and will then be adopted by WBC in June. Once adopted, an annual monitoring report will review if updates are required to the SPD.

2923 To consider what to do with the old notice board

PB will look into whether the schools can make use of this and if not, will attempt to sell it.

2924 To consider quotes for the contract for grass cutting and hedge cutting

No guotes had been received at the time of the meeting.

2925 To agree the expenditure for purchasing a sign showing the location of the car park by the village hall

DA will speak to local residents regarding this before a decision can be taken.

2926 To consider providing a shelter for teenagers to use at the Recreation Ground

The Clerk is to obtain formal quotes.

2927 To receive an update on the Churchyard

There was no update.

2928 To receive an update on vandalism and anti-social behaviour (ASB) in the village

There have been recent burglaries at the IAH farm and the pub and dogs stolen from by the pumping station. The telephone box has had some glass broken. Some youths have attempted to hang over the railway bridge to vandalise a sign.
