#### h) Groundwater

Notification has been received from the Environment Agency regarding continuation of the lowered level of the watercourse as it leaves Aldworth Road from Chaubury to tie in with an appropriate point downstream. Riparian owners have been notified about this.

At the time of writing the aquifer is ~53% full and rising more slowly after a spurt due to the heavy rain at the end of March and beginning of April. As the temperature rises the groundwater risk from heavy rain decreases.

### j) Neighbourhood Development Plan

A total of 429 responses was received to the recent survey and the steering group are approximately half way through inputting all the data.
